Special Regulations (non-German countries)

27th EE-European Show, 3rd European Junior Breeders Show, 94th German National Poultry & Pigeons Show, 49th National Nunior Breeders Show, 116th Lipsia-Show, 27th National Wild and Ornamental Fowl Show, Regional Championship of Saxony, Saxon Junior Breeders Show and District Show Leipzig, December 7-9 2012 Neue Messe Fairgrounds, Leipzig

The EE regulations for EE-European Shows, the General Show Regulations (AAB) of the BDRG and the following special conditions apply. The show management cannot be held responsible for the non-compliance with these rules nor with incorrectly completed entry sheets. The exhibitor agrees to having his address and phone number published in the show catalogue.

1. The individual contact persons for each country have to send their national entries in by 15 September 2012 by regular mail to the following address: Opressus – Post Box 1107 - 09306 Rochlitz. Entries by fax will not be accepted. Premature entry deadline possible upon reaching the maximum number of entries.

2. Entry fees (a-g include 1 € hand-over to the EE for every single entry)

a) Voliere displays (subject to confirmation): 31,00 € Turkeys, Guinea Fowl & Geese 1 male, 2 females;

Ducks, large chicken, bantam varieties 1 male, 4 females; Pigeons 8 birds

b) Trios & Couples: 16,00 € **c) Single entries:** 12,00 €

d) Ornamental Fowl: 12,00 € (1 male/1female combination only)

e) Junior Breeders: 6,00 € (Entry with club's confirmation, Junior Band mandatory)

f) New Breeds Section: 9,00 € **g) AOC-Class** 12,00 €

This class is reserved for non-standard colours in a specific breed. The colour however has to be standardized in another breed. Non-standard markings in a breed cannot be shown in this class. The AOC-class is not eligible for prizes.

h) Additional surcharge: 12,00 €

i) Show catalogue: 12,00 € (mandatory, except for junior exhibitors and officiating judges)

Non-German exhibitor have to enter their exhibits via the official contact person of their country. The contact person will collect the entry fees and forward the total amount to the show management. Individual entries from non-German exhibitors will not be accepted. The copy of the original entry sheet will only be returned after the entry fees have been paid in full.

3.Catalogue: Non-German exhibitors will receive their show catalogue in their respective national booth. The show catalogue is optional for junior exhibitiors, officiating judges will get a catalogue voucher with their clearing bill.

4. Veterinary Regulations:

- a) Birds from restricted areas due to outbreaks of Fowl Plague, Newcastle Disease, Avian Cholera, Foot and Mouth Disease or Swine Fever must not participate in the show.
- **b)** A valid certificate of vaccination has to accompany the birds to be shown.

Poultry has to be vaccinated against Newcastle Disease, pigeons need a vaccination against Paramyxovirosis. When using a life vaccine, the vaccination mustn't be older than 3 months, inoculation using inactivated vaccines mustn't be older than 6 months prior the show dates. Waterfowl requires a certificate of sentinel holding or a virological certificate.

The veterinary regulations valid at the time of check- in apply. You will receive your veterinary regulations along with the copy of the entry papers and the double band registration form. These forms have to be filled in.

- **5.** Check-in day is Tuesday, 4 December 2012 between 10 am 8 pm. Birds may only be checked in under supervision. The original of the band registration form has to be handed in, the second page of it is to be retained by the owner and be produced upon check-out of the animals. Joint transports get preference access, information on this subject can be obtained upon receipt of the show papers.
- **6. Sale:** The show management receives a handling commission of 15% of the listed sales price. A rebuy is not possible upon check-in of the animals. A rebuy possibility will be reinstated upon the begin of the official sales hours. Sales open on Friday, 7 December 2012 at 1 pm. Check-out of sold animals will not start before Friday, 7 December 2012 at 4 pm. Sales revenues will be paid out in the respective national booth of the vendor.
- 7. Cash prize donations by clubs will be listed as SE or SZ, cash prize donations by private persons shall be listed as PE or PZ. In accordance with the General Show Conditions XI 1e,f, these prizes have to be equal in monetary value to the cash prizes offered by the show: E-Prizes 12,00 €, Z-Prizes 5,00 €. The Lipsia Pendant will be awarded again as usual and be paid for from the entry fees.
- 8. Trophies and prizes will be distributed via the respective national booth.
- **9.** Group awards will be calculated according to the General Show Conditions AAA IX 5. Application forms for these awards will be printed in the show catalogue.
- 10. No modification or substitutions of entries can be accepted after the official closing date for entries.
- 11. Animal loss due to force majeure or unanticipated events will not be compensated by the show management. The exhibits will be guarded for the duration of the show. Should a loss of an animal occur due to faults of of show management, recompensation will be paid out according to General Show Regulations II,5. Missing judging cards upon returning animals do not justify a claim for damages. Empty carriers or baskets of sold or deceased exhibits will only then not be returned to their owner, if the owner has expressed his intention in writing on the band-registration form.
- 12. Upon loss of animals, proof has to produced in written form, stamped and signed by the Differences Department of the 27th EE-European Show. The Differences Department is located in every show pavilion. Last possible report of missing animals or falsely claimed animals is Sunday, 9 December 2012, 4 nm.
- 13. Please bear in mind that from March 2011 on, the city of Leipzig has been an environmental protection zone. Car access to this zone is only possible if your car is furnished with the green environmental compliance plaque. The Neue Messe and the roads leading up to the fairgrounds are not part of the environmental protection zone.
- **14. Last possible day for filing complaints is 31 January 2013.** Any claim has to be made in written form and sent to: Leipziger Rassegeflügelzuchtverein 1869 e.V., Ritter-Pflugk-Str. 2, 04249 Leipzig-Knauthain.
- 15. Court of jurisdiction is Leipzig.

EE-regulations for the titles of European Master and European Champion (abbreviated)

European Master: best collection (4 exhibits of the same breed and colour, mixed sexes, minimum result 376) in every breed with at least 20 exhibits, additional titles for every colour in the breed with at least 20 exhibits. In the case of a draw, all exhibitors will be granted the title "European Master". Collection Ornamental Fowl: 2 couples, same speces, minimum result 188 points.

European Champion: best exhibit in every breed with at least 20 exhibits, minimum result 95 points. Additional titles will be awared for every colour in the same breed with at least 20 exhibits. Breeds/colours with more than 40 exhibits will be awarded a title for both cocks and hens. The international jury and the head-judges are in charge of awarding the titles.

EE-medals will be awarded for every 400 exhibits by the head-judges. Every judge gets a European-pennant for awarding.
